Dawkins' Response

Dawkins cannot deny the first premise, so he has to deny the second:

The universe we observe has precisely the properties we should expect if there is, at bottom, no design, no purpose, no evil, no good, nothing but blind, pitiless indifference

The Atheist's Problem

In order to complain about "the evils of religion", or even to ask the question "How Could a Good God Allow Suffering?" the atheist has to acknowledge that good and evil exist, and therefore that God exists.

Final Thought

Why didn't God create a world with people who have free will but also with no evil and no suffering?

This is what God is doing.

But perhaps the only way to do so is to create people with free will, allow them to fall, and then redeem all those who chose to be redeemed.
